

Missouri State Medical Association Alliance Annual Report - 2019-2020

The 2019-2020 Alliance year began with the installation of officers at the annual MSMA Alliance Meeting in April held in Kansas City during the MSMA convention. Millie Bever was the installing officer. I was re-installed as president and Diana Corzine as president-elect, both for second terms. Also installed were Vice Presidents Kelly O'Leary (Health), Kirk Doan (Legislation), Jernifer Gast (Membership), Kathy Weigand (Foundation), Sana Saleh (Recording Secretary) and Debora Snyder (Treasurer.)

The theme I selected for my second term was Looking through Rose-Colored Glasses. This was a carry-on from my Look on the Bright Side Monty Python-inspired theme from the previous year. This was an optimistic approach to reflect changes in the world around us with many natural disasters, economic problems, the political climate, and health-related issues including the opioid crisis and the new electronic cigarette or vaping epidemic affecting our youth. Burnout wears down the medical profession from all sides with the need to defend medicine and patients from public opinion, invasive hospital and insurance influences, and scope-of-practice usurpers. At that time, we had not yet faced the even greater public health issues and burnout challenges for the health care workers, especially physicians, from the SARS-CoV-2 pandemic.

An Alliance Executive Board Meeting was held on May 29 in Columbia. I appointed additional officers to the board and all members presented their plans for the year. The dates and venue for Fall Conference in Hannibal was circulated and plans for Day at the Legislature to be combined with the MSMA White Coat Day on Mar 3 were discussed.

At the AMA Alliance annual meeting in Chicago in June, MSMA Alliance Past President Sue Ann Greco was sworn in for a second term as the national AMA Alliance Board Secretary, along with President Mary Beth Ellison from Ohio and her new officers. Missouri had excellent representation at the meeting.

Hannibal was the location I chose for the Alliance Fall Conference and appointed Sandra Murdock as conference coordinator. It was held Oct 29-30 at the Holiday Inn Express opposite the Medical Center. This was an excellent venue for our meeting. The program on Tuesday afternoon included invited speakers from the Hannibal Clinic recommended by Sandra Ahlum, MD. Eric Meidl, MD, an internist specializing in obesity working closely with the bariatric surgical team, spoke on the current management of obesity and discussed the pros and cons of various weight loss therapies and current trends, including intermittent fasting.

The American College of Surgeons' new initiative called *Stop the Bleed* was presented by **Patricia Hirner**, **NID**, a general surgeon. This is a hands-on course aimed at the general public on how to stop hemorrhage at a trauma site, such as a road traffic accident or a shooting. **Michael Bukstein**, **MD**, a vascular surgeon at the Hannibal Clinic, assisted in the demonstration which included the correct methods of applying compression to a bleeding wound, packing the wound with clean cloth or hemostatic gauze, and the use of tourniquets.

The Tuesday evening event was held at the Hannibal Country Club courtesy of members Sherry and Michael Bukstein. The Curator and Executive Director of the Mark Twain Boyhood Home and Museum Henry H. Sweets, III, spoke to the group after dinner. Henry grew up in Hannibal and is considered an international expert on Mark Twain. He spoke on Medicine and Pharmacy in the time of Mark Twain.

The Alliance Board meeting was held at the hotel on Wednesday morning. A majority of the board members was present, with two more participating by conference call. Pertinent board issues discussed included the transfer of the Alliance Scholarship funds to the MSMF which will handle future distribution to the Missouri medical schools.

In December, the Alliance Holiday Sharing Card was published with donor names in Show Me Alliance News, Missouri Medicine, and on the MSMA website. Proceeds from donations amounted to more than \$3300 to benefit the Foundations. Thanks to all who participated. The Alliance counties hosted many charity and fundraising events over the holidays to provide support for local food banks, a mobile food drive, shelters, school programs and local charities.

MSMA Council Meetings - Diana Corzine represented the Alliance at the October 12-13 MSMA Council in Jefferson City as I was unable to attend. The much-anticipated new format for a one-day Council meeting set for January 12 was conducted by conference call due to more bad weather. My written report had been sent and I participated in the conference call. I had planned to attend my final Council meeting at the time of the annual convention in St. Louis in April.

Day at the Legislature - this year, the Alliance moved its traditional Winter Board meeting and DATL to coincide with the MSMA White Coat Day to be held on Tuesday March 3 in Jefferson City. Legislative Vice President Kirk Doan arranged accommodation in a brand-new Holiday Inn & Suites and coordinated efforts on behalf of the Alliance with the staff at MSMA. Alliance members attended the winter board meeting the previous day and met for dinner at Madison's Café the night before for a briefing by the EVP Pat Mills, Director of Government Affairs Jeff Howell, and a short update by MSMA President James DiRenna, MD.

The MSMA Alliance Annual Meeting to be held in conjunction with the MSMA convention in St. Louis April 2-4 was cancelled due to the pandemic. The MSMA Council meeting scheduled at the usual time on Thursday April 2, was held by conference call. I gave the highlights of Alliance activities. A full written report was available for the councilors in the meeting packet.

I had invited speakers with two topics of interest to address the Alliance this year. The first was the St. Louis Society for the Blind and Visually Impaired – an extraordinary organization that gives many opportunities and new technology to teach skills to visually impaired individuals to empower them at home and at work. The second topic of great interest to the Alliance was on vaping. Rather than invite a separate local speaker to address our small audience on this topic, we adjusted the Alliance session so that attendees could join the MSMA members to hear the vaping talk in the general session by a Washington University Associate Professor of Psychiatry.

Sadly, all invited speakers for MSMA and the Alliance were cancelled along with the long-awaited Alliance Foundation Fundraiser Dinner with the James Bond theme. Thanks to Foundation Chair Kathy Weigand and her committee for all their hard work, in vain. Our Cabi mini-fundraiser fashion show was cancelled; we did not have the chance to complete our annual business meeting; to give my House of Delegates swansong speech; to present awards; to install our new board, especially incoming Alliance President Diana Corzine; or to enjoy the usual camaraderie. C'est la vie!

Recent updates:

On behalf of the MSMA Alliance, and at the suggestion of Sue Ann Greco, I applied for a grant from the Alliance Health Education Initiative to support a *Stop the Bleed* program in Missouri. We were awarded \$500. We will match this with unused funds from my president's budget to purchase the equipment for this project.

We needed to complete our annual business from the past year and install our officers. In lieu of the cancelled annual meeting, we will instead plan a Zoom business meeting on April 30 and a Zoom Awards and Installation ceremony on May 8.

And finally - Congratulations to Sue Ann Greco who was elected as the 2020-2021 AMA Alliance President! Sue Ann is only the 6th Missourian to be installed as AMA Alliance President. Many of us planned to attend the annual meeting in Chicago in June. Because of the pandemic the installation of officers will become a virtual meeting and will take place on Saturday June 6. The Missouri contingent will be honoring Sue Ann the best way we can with social distancing, as the event draws closer.

It has been a pleasure and an honor to serve as your MSMA Alliance President for the past two years. Thank you to my board and committee members who have helped make everything we did together possible!

MSMA Alliance Annual Legislation Report for 2019-2020

The 2020 MSMAA Day at the Legislature held March 2-3, 2020 in Jefferson City, Missouri in conjunction with the annual MSMA White Coat Day. We had 12 paid Registrants for the Day at the Legislature, 14 for dinner at Madison's Café, and 8 who were introduced at the House Gallery. Thanks to Liz Fleenor for all her help in organizing the event, and her attendance.

The 2020 MSMAA Day at the Legislature kicked off with the Winter Board Meeting of the MSMA Alliance held Monday afternoon in the Magnolia Conference Room of the Holiday Inn & Suites, 1590 Jefferson Street, Jefferson City, MO. That evening we had dinner at Madison's Café, attended by Registrants and some of the staff of the Missouri State Medical Association office in Jefferson City: Liz Fleenor, Jeff Howell, Heidi Geisbuhler, and Patrick Mills. Mr. Howell briefed us on the activities of the MSMA in the Legislature this year, and the MSMA position on many pending bills. Mr. Mills announced his upcoming retirement as Executive Vice President of the Missouri State Medical Association.

Tuesday morning the Day at the Legislature Registrants met at 9:00AM in the rotunda at the Missouri State Capitol along with the physicians participating the annual MSMA White Coat Day. Senators Jon Patterson and Bob Onder, two physicians in the Missouri State Senate this year, addressed the group. Representatives Lane Roberts and Holly Rehder also addressed the group. We were distributed advocacy cards that highlighted proposed legislation to define surgery for scope of practice purposes, limit vaping, and encourage prompt credentialing of providers by insurance companies. The speakers addressed legislative priorities including in person examinations related to medical marijuana prescriptions and the topics reflected on the advocacy cards.

At 10:00 am, the Day at the Legislature Registrants assembled in the Missouri House Gallery where Representative Dan Stacy of Independence, MO introduced them from the House floor. Representative Stacy also gave a summary of the mission of the MSMA Alliance, and some of our recent projects.

The Registrants broke into groups and distributed MSMA legislative advocacy cards to many of the House and Senate offices, and spoke with several elected officials. The fliers explained who the MSMA was, and highlighted various legislative bills that were supported this legislative session by the MSMA.

Many of the Registrants gathered with the physicians attending the White Coat Day for a box lunch on the third floor of the Capitol Building before heading home. The 2020 MSMAA Day at the Legislature was a successful event, and many expressed that they liked the new hotel venue.

In addition to the Day at the Legislature, I also attended the MSMA Annual Conference April 4-7, 2019 in Kansas City, called in to the Executive Committee meeting on May 29, 2019, attended the national AMA Alliance annual meeting in Chicago in June 8-12, 2019, and called in to the Fall Board Meeting on October 30, 2019.
